Behavior Contract: Cameron

I, Cameron, and We, Jenni and Boun (parents), agree to the following terms and conditions for this behavior contract.

I, Cameron, agree to be fully homework compliant for one full week. This means that I will use my planner as directed by Ms. Ranker; that I will have my teachers (Papac, Baudette, Oppezzo, Steinbergs an Polcari) initial after my planner entry every day at the end of class as per the convenience of the teacher in question; that I will complete all my assignments on time and in full, whether these assignments are from an SHS teacher or from Ms. Ranker; that I will take reading notes as directed by Ms. Ranker and/or make flash cards in order to document my reading assignments; that the assignments will be of a quality to receive a grade of C or better; that I will receive a grade of C or better on all tests and quizzes for the week in question. If I succeed in this, I will be able to take a platonic friend to a matinee movie at my parents' expense on the weekend following this success, or on the next weekend that I am in Redding if I am traveling to my father's house on the following weekend.

If I, Cameron, adhere to the above conditions for two consecutive weeks, I will be given a \$20 computer game as a reward. (If, on the following week, I miss an assignment or receive a grade of D or F on an assignment, quiz or test, I understand that the computer game is forfeit until I make up the work in question.)

If I, Cameron, adhere to the above conditions for eight consecutive weeks, I will get a "Get Out of Trouble Free" card that I can use with any parent/step-parent one time only. My transgression cannot extend to the illegal, immoral or to a serious violation of Rydell High School Behavior Code as an offence which violates any of these voids the card.

Beginning the week of \_\_\_\_\_, I Cameron, understand that my parents will sanction me for each missing planner entry, for each missing assignment, and for each grade of D or F on any assignment or quiz or test that I receive. For each missing planner entry, I will give up a desert. For each missing assignment, I will lose all social privileges on the following day until the assignment is made up. These privileges include, but are not limited to, the use of my cell phone, land line, computer games, television, and anything else that my parents deem appropriate within the limits of the law. I understand that personal comments and sarcasm from either me or my parents is not appropriate with regard to these sanctions. I understand that each week I start fresh with a chance to earn rewards, although some social privileges may continue to be withheld until missing work from the previous week is made up. The withholding of such privileges based upon my failing to make up late work within the calendar week is at the discretion of my parents, Jenni and Boon.
